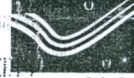

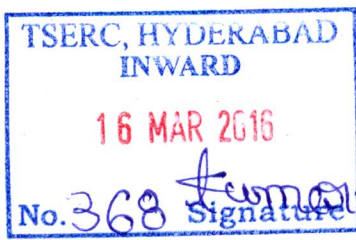

Sub:- ARR FY 2016-17 Tariff proposal - Public hearing - Objections
and Advices - Submission - Regarding.

The energy tariff of 2016-17 is consumer friendly in respect of category-LT-1(A), LT-I(B)(i), but the LT-I(B)(ii) is against poor and middle class consumers of Telangana and needs to roll back, on the following grounds :

- 1) The consumers availing up to 200 units per month will get attract of LT-I(B)(i) and the energy charges is Rs. 750-00 as per present tariff . But if it is increased by even in one unit ie., by 201 units, it attracts LT-IB(ii) tariff and energy charges goes up to Rs. 968.15.
- 2) At Present the billing month starts round about at 4th and ends by 17th of every month. As such the billing month is between 20 days to 40 days, and the poor and middle class consumers of 200 units per month, have to pay between Rs.470/- to Rs. 1506.05/- towards energy charges, as the tariff shifts from LT-I(B)(i) and LT-I B(ii), at no fault of him.
- 3) Even if the meter reader, visits the premises of the consumer, who consumes 200 units per month, by the date it self, but by a late of 5 to 6 hours, the envery charges goes fromRs. 750-00 to Rs. 968-15 having no fault of the meter reader or the consumer.
- 4) The consumer availing power supply of 400 units per month, has to pay the energy charges of Rs. 2590/- as per new tariff. But if he takes one more **additional service in the same premises**, bi-furcating the existed load, he has to pay two bills of Rs. 750/- each i.e., Rs. 1500/- only towards energy charges.

In the same way :

The consumer of 600 units has to pay Rs 4490/- , if he takes two more services, he will pay only Rs. 2250/- for his three services together, and

The consumers of 800 units has to pay Rs. 6390/- if he takes three more services, he will pay only Rs. 3000/- for his four services, in total.

5) Due to this the average revenue /specific revenue are decreasing month after month as the consumers are resorting to get Additional services, to escape this non telescoping billing.

Further, new consumers are resorting for multiple services in the same premises on the pretext of number of dwellings, to get safeguard from this defective tariff.

As such I request your kind Honour

- i) to rollback the LT-I B(ii) in total, and extend the telescope billing system LT-I B(i)
- ii) Billing should be based on 30 days X 24 hours, but not based on present calendar month system, which runs between 20 to 40 days.

If this defective tariff proposals are not set-right , as per the above suggestions, I am compelled to approach appropriate Court of Law/Forum for remedy, to save the hard earned money of poor and middle class people of our beloved Telangana, and to bring the Bangaru Telangana , as per dreams of our Hon'ble Chief Minister, Sri K.Chandra Sekhar Rao and also in the interest of Natural Justice.
