Sub: Objections / suggestions to the Public Notice regarding ARR filings and Tariff/Charges.

Ref: Public Notice issued by the TSSPDCL dated 10-03-2016, related to the filing of ARR and Tariff proposals including cross-subsidy surcharge proposals.

We would like to introduce "Kamineni Education Society with Institutions, Kamineni Institute of Medical Sciences, a Medical College, Kamineni Institute of Dental Sciences, and other Nursing Institutions and Sri Vidhya Peeth a residential School, at Narketpally, Nalgonda Dist. We have bed strength of 1500. We treat about four lakhs patients as outpatients, about forty thousand patients as inpatients and sixteen thousand emergency patients annually. More than 70% of the patients belong to the Aarogyasri, EHS, Arogya Bhadrata, and general patients who are provided treatment at subsidize tariff and to major extent Free. At any given point of time about hundred patients are treated in Intensive care units and all of them require continuous round the clock monitoring, ventilatory support and multi organ support care. Frequent int-eruptions and voltage fluctuations in power supply was serious problems for these patients inspite of the UPS and generator backup that we have.

We request you to kindly consider these facts and review the recently issued public notice for tariff policy (dated 10/03/2016) given by the Southern power distribution company of Telangana Limited. (TSSPDCL).

- 1. We request you to shift, hospitals from the HT 2 category to HT 6 category and provide preferential tariff. A separate category for Hospitals, at preferential tariffs is preferred.
- 2. Since Hospitals work on a 24 hour basis, we request relief from Time of Day Tariffs.
