

Retail Supply Tariff rate for Cat-VII B (Religious Places) - Certain Modifications - Urgent implementation of Tariff in total Mosques are situated in Telangana State - Req. Reg.

This is to bring to your kind notice that as per the purpose retail supply tariff rates, which is applicable with effect from 01-04-2015 to 31-03-2016 in respect of two Discom (TSSPDCL & TSNPDCL) State of Telangana.

The tariff rates for Cat-VII B (for Religious Places) proposed as follows:

SI. No.	Connected Load	Rate Per Unit
01.	For Load up to 2 KW	Rs.5/-
02	For Load above 2 KW	Rs.6.9

Now, it is brought under your notice that, every Mosque operates only during prayer times (i.e. 30-40 minutes) which result in increase in the connected load between 4 KW to 7 KW. Because of the increase in the connected load during prayer times attracting general purpose tariff rate i.e. Rs.6.9 per unit for all Mosque as against Rs.5/- per unit which is actually proposed for religious places.

Therefore Lit is requested to arrange to enhance the connected load slab from 2 KW to atleast 5 KW for all religious places, for benefiting them Rs.5/- per unit) which is actually proposed by your Commission and do the needful.
