

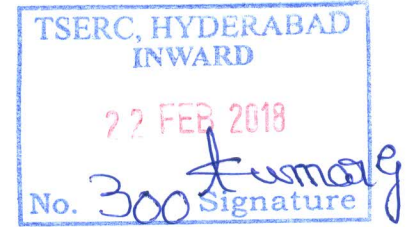

Sub : Objection / Suggestions by interested persons with regard to the ARR & ERC filings pertaining to the Cooperative Electric Supply Society Limited, Siricilla (CESS) – Reg.

We would like to attend the scheduled meeting to be conducted by Hon'ble Electricity Regulatory Commission to clarify / raise the following issues.

- 1) In absence of toll free number farmers are facing many problems in reporting failure of DTRs and loose lines and other supply related issues.
Hon'ble Commission is requested to issue direction to CESS to provide toll free number and online services.
- 2) How many fatal accidents are reported in CESS jurisdiction for the last five years and list of persons whom compensation / ex-gratia is paid and list of pending cases with the observations for not settling the cases.
- 3) Gollapally Mandal some electricity works was allotted under B.C. sub-plan by Collector of erstwhile, Karimnagar District and work was allotted to "Waddera Community persons" and work is executed as per specifications specified in order but so far Rs.1,07,000/- estimated amount is not paid to them.
- 4) Corruption charges with leveled against some employees and some were caught accepting bribe, what is the action taken against them during last five years.

- 5) Pole supply and other materials supplied by CESS is charged exorbitantly comparatively TSSPDCL and TSNPDCL.
- 6) Loose lines are not stringed and damaged poles are not replaced in many areas and AB switches not provided in many areas.
- 7) Not adhering to Standard of Performance (SOP) Schedule.
- 8) Submerged villages of Mid Manair Project for shifting of Poles and other infrastructure, what is the amount sanctioned by Government and what are the works carried out by CESS.
- 9) Publicity given / CGRF meetings conducted if any ?
- 10) Whether Transportation of DTR, Poles and other materials to the destination is executed by CESS or beneficiaries ?

We request the Commission to give opportunity to speak on the public hearing day.
