With reference to the cited above, TSNPDCL's suggestions/ objections/ comments on the **Suo-Moto** proceedings for determination of compliance of RPPO of obligated entities in O.P. No. 22 of 2023 are hereunder submitted.

- **A.** TSNPDCL has complied Solar RPPO fixed by the Hon'ble Commission for the all years from FY 2018-19 to FY 2021-22.
- **B.** TSNPDCL has complied Non-Solar RPPO fixed by the Hon'ble Commission for the all the years except FY 2019-20.
- C. There is a shortfall of 10.13 MU to comply Non-solar RPPO for the FY 2019-20. Whereas in remaining years, TSNPDCL has complied excess Non-Solar RPPO by 60.52MU in FY 2018-19, 3.23 MU in FY 2020-21 and 1.68 MU in FY 2021-22.
- **D.** In the report submitted by the TSSLDC, the previous year shortfall RPPO units only carry forwarded to the next subsequent years. The excess RPPO units were not carry forwarded to subsequent years.
- **E.** The year wise Non-Solar RPPO compliance of TSNPDCL duly excess/shortfall RPPO units carry forwarded to the subsequent years is herewith submitted.
