If the Petitioners fail to prove absolute compliance to the Hon'ble Commission's Tariff Regulations, it is prayed that the Hon'ble Commission may reject the instant Petitions in limine.

Notwithstanding the above it is also prayed that the Hon'ble Commission may conduct the Public Hearing one week after the submission of above illustrated information.

The Federation of Telangana Chambers of Commerce and Industry (FTPCCI) requests that the Hon'ble Commission may give due consideration to the severity of the situation and accordingly allow the prayers made by FTCCI and issue appropriate directions/orders
