## ANDHRA PRADESH ELECTRICITY REGULATORY COMMISSION

First Amendment to APERC Regulation No.3 of 1999

on

Method of recruitment and conditions of service of Commission's officers and staff

### Introduction

Whereas the A.P. Electricity Regulatory Commission (hereinafter referred to as "the Commission") notified the Andhra Pradesh Electricity Regulatory Commission (Method of Recruitment and Conditions of Service of officers and staff) Regulations, 1999 (Regulation No.3 of 1999) in A.P.Gazette dated 22-07-1999, containing inter-alia, the categorization of posts, strength of officers and staff, placement, recruitment and other conditions of service, qualifications for officers and staff of the Commission;

And whereas the Commission proposed conversion of the post of Dy. Director (Media) into that of Executive Assistant to the Commission Secretary;

And whereas the Government of Andhra Pradesh have communicated their acceptance to the proposal of the Commission in their letter No.4036/Pr.III(1)/2005, dated 21-02-2006 subject to amendment to the said Regulation No.3 of 1999;

Now, therefore, the Commission, in exercise of the powers vested with it under Sub-Section (1) and Clause (b) of Sub-Section (2) of Section 54 read with Sub-Sections (2) and (4) of Section 8 of the Andhra Pradesh Electricity Reform Act, 1998, and Section 91(2) of the Electricity Act, 2003, read with Clause 4 (1) and Appendix-1 of the aforementioned Regulation No.3 of 1999, and all other powers enabling it in that behalf makes the following Amendment Regulation to the said Regulation No.3 of 1999, namely:-

1. Short title, commencement and interpretation

(i) This Regulation may be called the A.P.Electricity Regulatory Commission (Method of Recruitment and Conditions of Service of Officers and Staff) (First Amendment) Regulation, 2006.

(ii) This Regulation shall come into force on the date of its publication in the Andhra Pradesh Gazette.

2. (i) The existing item (xxiii) in Clause 4 (i) (a) in the Regulation No.3 of 1999 shall be substituted with the following:

“Executive Assistant to Commission Secretary”

(i) The existing entries against Serial No.22 of Appendix-1 shall be substituted with the following:
